This website is partially compliant with the requirements of Appendix A of the accessibility standard UNI CEI EN

301549 due to the following cases of non-compliance

Non-accessible content

The content listed below is not accessible for the following reasons of non-compliance with Law No. 4 of 9 January 2004:

- C.9.1.1.1 - Some non-text content presented to the user does not have an equivalent text alternative that serves the same purpose;
- C.9.1.3.1 - In certain cases, the information, structure or correlations conveyed by the page presentation cannot be programmatically determined (or are not available in text form);
- C.9.1.3.3 - Some instructions given to understand and operate content are based only on certain sensory characteristics of components such as shape, colour, size, visual location, orientation or sound;
- C.9.1.4.1 - In some cases colour alone been used to identify a purpose or distinguish information or a function;
- C.9.1.4.3 - The visual representation of text and images containing text does not always have the required minimum contrast ratio, with the exception of what is set out in the regulations (e.g. logos);
- C.9.1.4.4 - With the exception of subtitles and images containing text, certain texts cannot be resized up to 200 per cent without using assistive technologies and without losing content and functionality;
- C.9.1.4.10 - Content that does not require a two-dimensional representation (such as data tables or maps) does not adjust correctly when the size displayed by the user programme changes;
- C.9.1.4.11 - For certain essential components, even in different states, the colour contrast compared with adjacent elements does not exceed a ratio of 3:1;
- C.9.1.4.12 - When changing the spacing of text in relation to the line height, spaces between paragraphs, letters or words, there is some loss of information or content;
- C.9.1.4.13 - In certain cases, when hovering or keyboard focus makes content visible and hidden, there is no mechanism available to delete the additional content without moving the mouse pointer or keyboard focus, the pointer cannot be moved to additional content without it disappearing, or the additional content doesn't remain visible until the hover or focus is removed, the user deletes it, or its information is no longer valid, with certain exceptions;

- C.9.2.1.1 - Certain functions cannot be used via the keyboard (or interface with similar input);
- C.9.2.2.1 - There is a time-dependent element or event where none of the following is possible: deactivating the time limit before reaching it, setting the time limit, being unable to extend it up to 10 times, or the user not being notified before time expires, with the exception of what is set out in the regulations;
- C.9.2.2.2 - Certain animations, flashing, scrolling or auto-updating of information initiated automatically, which last longer than five seconds or are presented in parallel with other content, do not have mechanisms to interrupt or hide them;
- C.9.2.4.1 - A mechanism is missing for skipping blocks of content that are repeated on multiple web pages;
- C.9.2.4.2 - Certain web pages do not have titles describing their subject or purpose;
- C.9.2.4.3 - On certain web pages that can be navigated sequentially and where the navigation sequence affects their meaning and operation, some objects that might receive focus do not receive it in the right order to preserve their meaning and operation;
- C.9.2.4.4 - The purpose of certain links cannot be determined by the link text or by the link text together with adjacent content;
- C.9.2.4.6 - Headings and/or labels do not sufficiently clarify the content or functionality;
- C.9.2.4.7 - On certain interactive elements, the focus indicator is not visible;
- C.9.2.5.3 - For certain user interface components with labels that include text or text images, the name read by the aids does not contain the text that is visually presented;
- C.9.3.2.2 - When the user changes the setting of any interface component (input), a change of context occurs;
- C.9.3.2.3 - Certain navigation mechanisms that are repeated on several web pages within a set of web pages do not appear in the same order;
- C.9.3.2.4 - Certain components with the same functionality within a set of web pages are not consistently identified;
- C.9.3.3.1 - In certain cases, when an insertion error is automatically detected, the item in error is not identified and/or the error is not described in the text;
- C.9.3.3.2 - In certain cases, no labels or instructions are provided when the content requires user input actions;
- C.9.3.3.3 - If an entry error is identified and suggestions for correcting it are known, these are not provided to the user, with the exception of what is set out in the regulations;
- C.9.4.1.2 - In certain cases, user interface components (including: elements of a module, links and script-generated components...), name, role, status, properties and values, are not correct or set or the user and their assistive technologies are not notified when these change;
- C.9.4.1.3 - In certain cases, status messages are not presented to the user in such a way that assistance technologies interpret them without shifting the focus.
